Part of our primary missions in safeguarding the community is to join in partnerships with local businesses to control crime. I would like to commend security officers Freddy Rivera and Francisco Donovan for displaying a high level of integrity during a recent burglary incident that took place in the fashion district.

Two full days were spent meeting with Cincinnati police officers, community activists and other members of the community.



The LAPD was able to provide the Cincinnati Police Department with assistance based on proven tactical response techniques used during the Democratic National Convention.

Department employees assessed tactical strategies to diffuse the situation and examined what was needed to begin the healing process in the community.

The Department analyzed the factors that caused a three-day clash between the police and the community resulting in two million dollars damage.

LAPD command staff and other key Department personnel were briefed on the results of the visit and will use the knowledge gained to develop outreach efforts and tactical strategies that will increase productivity in the Department.

## 30th Annual Los Angeles Police-Celebrity Golf Tournament

It was a “par” year again for the Los Angeles Police-Celebrity Golf Tournament which was held on Saturday, May 19, 2001, at Rancho Park Golf Course. The tournament returned to the westside this year after last year’s tournament was held at Woodley Lakes in Van Nuys.

Comedian George Lopez, host of Mega 92.3 Morning Radio Show, and Chief Parks kicked off the tournament after an awesome opening ceremony demonstration by the Department’s SWAT Unit.

Autograph seekers and stargazers appeared with pens and cameras in hand to get a glimpse of their favorite stars. Entertainers such as Eddie Van Halen, Steve Guttenberg, Meatloaf, Paula Trickey, Jamie Farr and Elke Sommer were just a handful of the celebrities who swung golf clubs in support of the Los Angeles Police Memorial Foundation.

The tournament is the only major fundraising event for the Foundation. The Foundation provides assistance to Department personnel in catastrophic circumstances resulting from death, illness or injury. Since its inception in 1972, the Foundation has granted more than \$7.5 million for medical, funeral and education expenses to sworn and civilian Department personnel and their families.

A number of static displays were positioned along the fairways of the golf course. The displays consisted of several of the Department’s specialized units, and the LAPD mobile museum, just to name a few. In addition, children in attendance enjoyed carnival rides and a popular face-painting clown.

The 1<sup>st</sup> place foursome, with a score of 62, consisted of actors Corey Haim and Joel Murray, L.A. Dodge Public Affairs Coordinator Joe Saldana and Police Surveillance Specialist Mike Hayes from SID. Chief Parks and his team shot a 77 and, therefore, were awarded the “Duffer Award” for the worst score.

Sergeant Larry Taylor of Devonshire Area, Detective Ron Phillips of West Los Angeles Area and Officer Josh Chong of Southeast Area, prevailed as winners in the “Closest to the Pin” competition.

Last year, the Department unfortunately lost two of its own while on duty: Officer Robert Mata and Officer Louis Villalobos. It is because of this golf tournament that the Foundation is able to provide financial assistance to the families of fallen officers as well as other families in the Department.

The golf tournament wouldn’t be as successful if it were not for the Foundation staff, the planning committee and the Department’s support.



# Chief Parks' Address at LAPD Memorial Ceremony

Good afternoon and welcome to the Los Angeles Police Department's National Police Week Memorial Ceremony. This event is one of many ceremonies being held across our great nation, where tribute is being paid to the thousands of law enforcement officers who lost their lives in the line of duty. Today, we gather to honor and pay tribute to fallen members of our own LAPD family. I want to assure each of you here today that these lives were not lost in vain. These valiant LAPD officers made the ultimate sacrifice while responding to the highest calling in life – Public Service.

We gather proudly in front of this, our Department's most sacred monument, the Los Angeles Police Memorial, to honor our own. This solid black granite structure serves as a reminder to each one of us, day in and day out, that on any given day, we, too, could be called upon to pay the ultimate price... to sacrifice our lives so that peace and freedom in our City can be maintained and strengthened.

There are 194 names inscribed at the base of the memorial. I believe in my heart that, given the chance to do it all over again, each would choose once again to join the LAPD family. And, what a family it is – proud, strong, and brave. For each officer listed, we share a tremendous sense of loss, because for some of us here, a husband, wife, family member, loved one or partner is no longer a part of our everyday lives. We have vivid memories, which we hold onto dearly, and yet they are not enough to fill the void. This is why we pay a special tribute to the families of these fallen heroes. You shared and played a part in every aspect of their lives. You hurt when they hurt. You stayed up nights, worrying about your loved one's well-being. You shared in their triumphant moments and victories.

While we often feel hurt, angered, and demoralized by the circumstances that led to the loss of these lives, we must not forget the many heroic acts of

bravery that exemplified their lives. These heroic acts led to the ultimate sacrifice – losing their own lives in service to others.

I have spoken in the past about the bitterness that can also come as a result of these lost lives. My hope and prayer is that you will not be embittered by the loss of your loved one. I hope you can sense the care and the love of the members of this Department. You are an important part of our family. Please take comfort in knowing that will never change.

This year, we salute the memory of another brave officer whose name we must sadly add to the memorial: Officer Robert Joe Mata.

In the highest tradition of bravery and valor in public service, Officer Mata paid the ultimate price while responding to a call for backup by another officer, who was investigating a stolen vehicle. He knew full well the potential dangers when he suited up in his LAPD blues on that fateful day, and yet he would not be deterred. He chose to answer this important call. He chose to protect and serve. Officer Mata was in his mid 20s. He left behind a wife and two small children. He, and they, will not be forgotten.

His legacy is added to that of other recent fallen LAPD heroes – Louis Villalobos, Brian Brown, Filbert Cuesta, and Steven Gajda. It is ironic that the trials of those who killed Officers Cuesta and Brown are in session today. All of these officers left behind young children and other family members. We must extend our arms around them and continue to embrace them as part of our LAPD family.

These officers will not be forgotten. Their sacrifices will continue to motivate and inspire us all to a greater understanding of public service and the tremendous price of protecting and safeguarding the most basic rights and freedoms of the people of Los Angeles.

In these difficult times in our Department's history, we must

recommit ourselves to community partnerships, hard work, integrity, and excellence. We must focus on our primary mission – Community Safety! We must embrace a full spectrum approach to reducing the fear and incidence of crime and enhancing the quality of life in our neighborhoods. Our Department, government and community partnerships must be strengthened and revitalized. Our leadership must be proactive, boldly promoting healthy working relationships, trust, integrity, and respect. Our vision must be focused to the future while always striving to achieve higher standards. As we salute these fallen heroes today, we are reminded of how far we have come, and yet we also realize that we can and will do better.

I give special recognition to each officer here today – for heroically heeding this high calling, and I personally thank them for their service and being here to pay tribute and respect to those who lost their lives in the line of duty.

I thank all of the family members, friends and loved ones here today for your support, your caring, and yes, your sacrifice.

In closing, I am reminded of the words of Solomon, who so eloquently wrote in one of the Proverbs: "The path of the just is like the light of dawn, that shines ever brighter unto the perfect day." In my own heart and mind, that perfect day will be when we gather here annually in front of the Los Angeles Police Memorial and rejoice because there are no new names to be added to the monument.

In the meantime, we will not be disheartened. We will not despair. We will not give in to defeat. On the contrary, those to whom we pay tribute today inspire us and lift us higher. Their dedication, bravery and sacrifices strengthen us, encourage us, and propel us forward to meet and excel in the challenges that surely lie ahead.

# Civil Rights Consent Decree Overview

Following the discovery and disclosure of the Rampart Area Corruption Incident by the Los Angeles Police Department, the United States Department of Justice (DOJ) notified the City of Los Angeles that it intended to file a civil suit alleging that the Department was engaging in a pattern or practice of excessive force, false arrests and unreasonable searches and seizures.

Whenever the DOJ has reasonable cause to believe such violations have occurred, they may obtain a court order to eliminate the pattern or practice. On that basis, the DOJ has entered into consent decrees with other law enforcement agencies throughout the United States including the Pittsburgh, Pennsylvania Police Department; Steubenville, Ohio Police Department; and the New Jersey State Police.

A consent decree is an agreement between involved parties submitted in writing to a court. Once approved by the judge, it becomes legally binding.

In making these allegations, the DOJ recognized that the overwhelming majority of Los Angeles police officers perform their difficult jobs in a lawful manner. The City denied the allegations in the DOJ complaint and entered into negotiations with DOJ. However, to avoid potentially divisive and costly litigation and to promote the best available practices and procedures for the Department, the City entered into the Civil Rights Consent Decree.

The Consent Decree will last a minimum of five years during which the Department must demonstrate substantial compliance with the Decree's provisions.

The Consent Decree is intended to promote police integrity within the Department and prevent conduct that deprives individuals of their rights, privileges, or immunities

protected by the Constitution of the United States. The Consent Decree places emphasis on the following nine major areas:

- ◆ Management and supervisory measures to promote Civil Rights Integrity;
- ◆ Critical incident procedures, documentation, investigation and review;
- ◆ Management of Gang Units;
- ◆ Management of Confidential Informants;
- ◆ Program development for response to persons with mental illness;
- ◆ Training;
- ◆ Integrity Audits;
- ◆ Operations of the Police Commission and Inspector General; and,
- ◆ Community outreach and public information.

The Consent Decree includes several recommendations from the Rampart Board of Inquiry Report. Additionally, many of the Consent Decree's provisions mandate that the Department continue existing policies. Some of the more complex or major provisions in the Decree call for the following:

- ◆ Development of a Risk Management System (TEAMS II);
- ◆ Creation of a new division to investigate all Uses of Force formerly investigated by Robbery Homicide Division and Detective Headquarters Division;
- ◆ Creation of a new division to conduct audits Department-wide;
- ◆ Creation of a Field Data Capture System to track the race, ethnicity or national origin of motorists and pedestrians stopped by Department employees;
- ◆ Creation of an Ethics Enforcement Section within Internal Affairs Group (IAG);
- ◆ Transfer investigative authority to IAG, for all serious personnel complaint investigations;
- ◆ A nationwide study, by an independent consultant, of law enforcement agencies' protocols for dealing with the mentally ill. The study will serve as the Department's foundation for refining its own system;
- ◆ A study by an independent consultant of the Department's training programs; and,

# Civil Rights Consent Decree Overview

◆ Creation of an Informant Manual and database.

On November 2, 2000, the City Council and the Mayor approved the Consent Decree negotiated between the City and the DOJ. However, the Consent Decree was not immediately entered (i.e. approved and signed) by Federal District Court Judge Gary A Feess. Nonetheless, the Department formed the Consent Decree Task Force (CDTF) within Administrative Group to plan for, coordinate, track, monitor and report on the Department’s compliance with the Decree’s provisions.

The CDTF conducted an exhaustive content review of the Consent Decree to determine how best to proceed with the implementation of its mandated provisions. A management plan was developed. The plan included the assignment of approximately 64 major administrative projects, intended to collectively result in Department compliance.

On February 1, 2001, the City was required to submit its first status report on compliance progress. However, at that point, the Consent Decree was still unsigned by the Federal Judge and the Independent Monitor to whom the report was to be submitted had not yet been selected.

Despite these unforeseen delays, the Department published its Preliminary

Implementation Plan on February 1, 2001 and submitted it to the Board of Police Commissioners as the Department’s first progress report. Additionally, on February 15, 2001, and May 15, 2001, the Department filed Internal Discipline Quarterly Reports mandated by the Consent Decree.

On April 8 and June 1, 2001, respectively, Critical Incident Investigation Division (CIID) was activated, and the Department submitted its Annual Audit Plan to the Police Commission.

On May 18, 2001, the City Council approved the selection of Michael G. Cherkasky, President and CEO of Kroll Associates Inc., as the Consent Decree’s Independent Monitor. The Independent Monitor will function as an Agent of the Federal Court and will monitor and report on the City’s compliance

progress to Judge Feess.

The Court formally entered the Consent Decree into law on June 15, 2001. In the upcoming month, Department employees can expect to receive Consent Decree-related orders, notices, and training, articulating new operational policies and procedures.

Wilshire and Hollywood Area patrol officers recently began a pilot program to evaluate the use of hand-held computers for motor vehicle and pedestrian stops. Data collection is scheduled to begin Department-wide by November 1, 2001.

Lastly, the transition of investigative responsibility from RHD and DHD to Critical Incident Investigation Division (CIID) has been completed and officers will now see detectives from CIID conducting the administrative investigations at all Officer-Involved Shooting (OIS) and Categorical Use of Force scenes.

The men and women of the Los Angeles Police Department are deeply committed to serving all the people and all the various communities of the City.

Compliance with the Consent Decree is the baseline for, and not the ultimate standard, by which the Department’s commitment to excellence will ultimately be measured.

The communities of Los Angeles expect and deserve the finest service possible from their police officers. To that end, the Department shall consider the Consent Decree as only a part of a more comprehensive effort to provide the highest level of protection and service.

## Officers injured in the line of duty

On May 23, 2001, Officer Jeff Nuttall was injured when he and five other officers responded to a request for backup for a robbery suspect at Sherman Way and Wilbur Avenue.

The suspect fled the scene and officers pursued him to the intersection of Balboa Boulevard and Balboa Place. The suspect fired multiple gunshots from a handgun, wounding Officer Nuttall.

The suspect drove to Roscoe Blvd and Home Depot Place, where his vehicle became disabled. The suspect got out of the vehicle and fired at the officers. The officers and detectives returned gunfire, wounding and incapacitating the suspect.

Los Angeles City Fire Department Paramedic pronounced the suspect dead at the scene. Officer Nuttall was transported to a local hospital where he was treated and released.

In a separate incident, Officer John Harrison of the metropolitan Division was injured when he and four other officers pursued a murder suspect in the 2400 block of Meadowvale Avenue.

The suspect refused to surrender and shot at the officers with two handguns, wounding Officer Harrison.

Officer Harrison suffered a through-and-through shot to his right leg right knee and a gunshot wound to his right hand middle finger. Officer Harrison was transported and admitted to a local hospital where he was treated for his wounds and was reported to be in satisfactory condition.


These incidents remind us of the importance of safety in our day-to-day responsibilities.

In one incident, Officer James Bergman tracked down a wallet owner in Maryland and offered to personally mail it back to them.

"Police Officers have only one legacy and that's their integrity and their honesty," said Police Chief Bernard Parks. Their word means a lot and people believe in that badge


