

## MSD Plants A Tree in Memory of Lori Gonzalez



On November 3, 2001, Management Services Division personnel (MSD) planted a tree in Elysian Park in memory of Lori Gonzalez, granddaughter of Chief Parks and Bobbie Parks, who tragically died on May 28, 2000, the victim of gang violence.

The tree, a Tebebebuia Ipe or Pink Trumpet Tree, was planted near the Old Lodge, the area now renamed Montecillo de Leo Politi. Lori's mother, Felicia Parks, and other members of the family were on hand for the presentation. Lieutenant Leonard Knight, representing Captain Thomas Runyen, gave welcoming remarks.

Since 1979, more than 600 trees have been purchased and planted in Elysian Park by members and friends of the Citizens Committee to save Elysian Park (CCSEP) as loving memorials to friends and relatives.

In a cooperative effort with several organizations, supporting the Recreation and Parks Commission Fire Restoration Fund, memorial tree planting began after a devastating fire in Elysian Park on June 16, 1981.
