3. REPORT OF THE CHIEF OF POLICE

Chief Beck reported on the third annual Run to Remember that occurred on April 8, 2018, an athletic event with over 5,000 participants. A traffic accident occurred earlier in the morning. A produce truck turned in front of a black and white vehicle injuring two police officers en route back to their divisions after working MTA. Both officers are stable and in good condition. On Monday, April 9, 2018, an Officer-Involved Shooting occurred in Topanga Division. Uniformed officers became aware of a stolen vehicle via a Lojack hit. The officers attempted to detain the vehicle and the driver. The driver exited the vehicle and fled on foot. Officers initiated a foot pursuit and during the pursuit in an alley, the suspect produced 38-caliber revolver and fired multiple rounds at the officers. The officers returned fire killing the suspect and one of the officers sustained a gun-shot wound to the left leg, and the other officer sustained scrapes and bruises. The 38-caliber pistol was recovered from the scene with six expended rounds in its chamber. Body-worn video shows the suspect pointing the weapon and firing at the officers.
