3. **REPORT OF THE CHIEF OF POLICE**

Chief Moore reported an officer-involved shooting involving a canine. He stated there were no other categorical use of force to report. Deputy Chief Kato is working with a number of organizers for a series of marches in recognition of the Armenian Genocide. Chief Moore thanked the organizers for working with the Department. Chief Moore recognized Deputy Chief Arcos. Next Tuesday is the historic May Day marches and demonstrations. They will be receiving additional briefing on the events and he thanked the organizers for working with the Department to facilitate the demonstrations and marches. This past weekend, the Department worked with the CHP and the County Sheriffs for a 3-day street racing task force. This collective effort will continue to take further precautions and enforce street racing which has caused many injuries. Chief Moore recognized Commander Chow and Captain Kowalski in the Olympic Area, they sought out donations from a series of dress makers in the area and provided over 300 prom dresses to underserved youth, starting with cadets and local HACLA, so that students may attend their prom. They also collected over \$7,000 in donations for those students to attend their prom. In the Hollywood area, a group of 75 riders met this morning to begin a ride across the country on bicycles in tribute to fallen officers. They will meet with other cyclists during police week.
