## **REPORT OF THE CHIEF OF POLICE**

Chief Beck mentioned that ten shootings occurred over the past weekend. Four occurred within Operations South Bureau, three occurred within Operations Central Bureau, two occurred within Operations Valley Bureau, and one within Operations West Bureau. Two of the incidents resulted in the death of the individual that was shot, both were in Operations Central Bureau.

Two Officer Involved Shootings one on Tuesday, at about 9:00 p.m. hours in Harbor Area. Uniformed patrol responded to a man with a gun, radio call. Officers arrived and were directed by witnesses who said the potential suspect was armed. Officers exited their vehicle and the suspect was struck by police fire while the Department vehicle hit the suspect. The suspect died at scene because of the gun-shot wounds and a plastic toy hand gun was recovered at the scene. Investigation continues.

On June 8, at 3:15 p.m. in the afternoon, Hollenbeck patrol officers initiated a stop with a known 18<sup>th</sup> street gang member who was previously arrested for possession of a hand gun a week prior. Officers observed a bulge in the shorts, in the area where a hand gun can be secreted. Officers attempted to verbally get compliance and a physical altercation began. One of the officers observed the suspect hold a gun during the altercation. Officers disengaged, and a shooting occurred and he was struck and taken into the custody. A 9mm handgun was recovered at scene and he is currently recovering from injuries.
