Hearing Examiner's Recommendation(s) for Panel action:

1. *The temporary permit be continued for another six months on the condition that respondent, in writing, agrees to the following conditions:*
 - a) *The corporation shall within 30 days hereof, provide the names of all its shareholders, directors, officers, manager, and assistant manager.*
 - b) *The commission is authorized to conduct background checks on all of the person whose names are provided in compliance with condition number 1.*
 - c) *The corporation shall not commit any violations of any stature during the six month extension. Should there be such violation, or a violation of any of these conditions, the Commission may, upon seven days written notice to the corporation, cancel the temporary permit.*
 - d) *The corporation shall employ one or more managers or assistant managers to be present at the club during all business hours.*

In the event the corporation fails to agree to the above enumerated conditions, undersigned finds that there is sufficient evidence to support the Commission's accusation denying the applied for permit and that the board of Police Commissioners should affirm the denial. Said denial is the decision of undersigned.
