CASE SYNOPSIS:

The 29 year-old victim was talking with several other individuals in the 2200 block of East 114th Street. The suspect approached the group on foot, and fired multiple gunshots striking the victim and a second person. The suspect fled the scene on foot. Victim Griggley died later at a hospital as a result of the walk-up shooting.

**DATE/TIME:** Tuesday, Jan. 28, 2014 6:45 PM

**LOCATION:** 11600 Block South Avalon Boulevard

**CASE SYNOPSIS:**

The 57 year-old victim was walking southbound in the 11600 Block of South Avalon Boulevard toward his residence. Five suspects confronted and then attacked Garcia by punching and kicking him multiple times in the head and torso. Garcia fell to the sidewalk at which point the suspects robbed him. The suspects fled the scene on foot after the robbery. The victim died a few days later at a hospital as a result of the beating.

**CASE SYNOPSIS**

**DATE/TIME: Saturday, April 21,2012 1:35AM**  
**LOCATION: Century Blvd/San Pedro Street**

**CASE SYNOPSIS:**

Kendrick Blackmon was with two others driving his vehicle southbound on San Pedro Street at Century Boulevard. The suspects drove up alongside in their vehicle, and fired multiple gunshots, striking Blackmon. The suspects then fled in their vehicle. Paramedics transported Blackmon to a local hospital where he later died as a result of the car-to-car shooting.
