**CASE SYNOPSIS:** At approximately 10:29 PM, the victim was standing in front of his apartment building, when 2-4 suspects drove southbound in a green or blue colored sedan. The suspects fired multiple gunshots. The victim was struck, and died as a result of the drive-by shooting.

**CASE SYNOPSIS:** At approximately 10:28 PM, the victim was standing in the street with numerous other people watching a neighborhood fireworks display. Two suspects approached on foot and fired multiple times at the group, striking several people. Victim Tillet died later at the hospital as a result of the walk-up shooting.

**LOCATION:** Crenshaw and Vernon

**CASE SYNOPSIS:** The victim was the front passenger in a 1973 Buick Electra along with 2 other friends. They were traveling northbound on Crenshaw Boulevard approaching Vernon. A grey or silver vehicle, also traveling north on Crenshaw, pulled next to the passenger side of the Electra. One suspect began shooting into the victim's vehicle. The victim was struck multiple times by gunfire and died later at a hospital as a result of the drive-by, car-to-car shooting.

The victim was visiting family for the Christmas holiday. While eating dinner, Woods was suddenly struck by gunshots that travelled from the street, through the wall, and into the interior of the home. He died at a hospital the following day as a result of the unprovoked attack. The group had just returned home from visiting relatives. A white SUV traveling eastbound on 38th Place at Cimarron Street stopped in the intersection. The front passenger of the SUV fired from the vehicle, attempting to shoot a male Black pedestrian standing in the street. The bullets struck the victim's vehicle instead, wounding the victim.
