HOLIDAY CRIME PREVENTION TIPS

The holiday season is approaching fast. Many of us are looking forward to spending time with friends and family. The holiday season provides crooks with greatly increased opportunities to walk away with precious gifts.

Please keep these tips in mind as the holidays draw near:

When you are out shopping, please keep in mind our phrase “Lock it, Hide it, Keep it” and tuck away your purchases into the trunk.

Be alert and aware of your surroundings as you leave stores and coming/going from your residence. If you see someone that looks out of place on your street as you leave, call a neighbor to alert them.

Holiday shopping can be hectic with large crowds. If you are going shopping with a child, teach them to go to a store clerk or security officer in case you get separated.

Holiday lights are pretty, but don't run electrical cords through doors or windows if it prevents you from locking up.

A holiday tree displayed in the front window and surrounded by gifts may be irresistible to the passing thief (keep the gifts hidden away until you will be home and ready to celebrate).

Think twice before posting on social networks (Facebook, Twitter, etc.) that you are out of town and discuss this with your children.

If travelling, try to load up your car inside the garage or out of view from crooks passing by. Dragging suitcases out to the curb is a giveaway that no one will be home for a while.

Keeping a clean car in the driveway makes it look like someone is home. If you are going to travel, try to leave a car in the driveway or ask a trusted neighbor to park there.

Boxes and packaging of your expensive gifts should be cut up and disposed of so that trash day doesn't advertise the newly acquired contents of your home.
